8. Receive a progress report by the Regional Trails and Open Space Workgroup

No discussion regarding the substance of any such proposed topic shall occur and no action shall be taken regarding the proposal.
14. **Citizens Participation.** Public comment during this portion of the agenda must be limited to matters within the jurisdiction of the Commission. No subject may be acted upon by the Commission that subject is on the agenda and is scheduled for action. If you wish to be heard, come forward and give your name. The amount of discussion on any single subject, as well as the amount of time any single speaker is allowed, may be limited.
